## WLBP Farm Records Events

During December 2019 and January 2020, WLBP conducted Farm Records events in conjunction with Lantra and Farming Connect.

We visited 18 different locations covering all of Wales. The events included an introduction to WLBP, an overview of the FAWL scheme and an in-depth demonstration of the Farm Records facility.

We had a great turnout at all locations and numbers ranged from 20–60 people at each location. The feedback received was very positive, with many members realising the benefit that Farm Records could offer their businesses.

It was also a great opportunity for members who are already using the system to give their feedback on the facility. From this, we will look at improving and updating the facility to suit the needs of our members, and to keep up to date with any future changes in legislation.

The members who attended were surprised by the capability of the system in maintaining statutory farm records, completing medicine books, health plans and your FAWL Management Record Book.

The phone app proved very popular, with many attendees commenting on how easy it is to input records while on farm.

# Organics and the EU Exit transition period

On 31 January the UK left the EU and entered into a transition period until the end of 2020. During this transition period, businesses will be able to trade with the EU on the same terms as they do now. There are no immediate changes and organics will continue to follow EU rules until the transition period ends including import/export rules and labelling requirements.

The rules for organic production will remain the same as now. The UK continues to operate under Council Regulation (EC) No 834/2007 and Commission Regulations (EC) Nos 889/2008 and 1235/2008 which also apply in the EU.

**SEED DEROGATION:** For 2020 only the percentage of organic seed within grass and forage seed mixes has changed, due to a shortage of seed caused by the 2018 drought.

Derogation required prior to purchase	Derogation before inspection	No derogation required
Less than 50% organic grass and forage mixes	50%–99% organic grass and forage seed mixes	100% Organic Seed
Less than 70% organic arable silage and wholecrop mixes	70%–99% organic arable silage and forage seed mixes	
100 % non-organic seed		

Seed mixes to be sown during 2021 must contain a minimum of 70% organic seed, even if purchased in 2020.

## Regulations on Oil Storage in Wales

Regulations to protect the environment and properties as a result of spills from oil storage containers will be extended to all tanks from 15 March 2020.

The regulations set standards for oil storage facilities which aim to prevent the escape of oil and the resulting risk of water pollution and damage to land and property. The principal requirement is for secondary containment to prevent any leaks from an oil storage facility escaping into the wider environment. These requirements apply to all new oil storage facilities from 15 March 2016. Existing oil storage facilities serving non-domestic properties will now need to be compliant from 15 March 2020. Domestic storage tanks in place before 15 March 2016 remain exempt until they are replaced.

Agricultural fuel oil storage facilities, which had been covered by the Silage, Slurry and Agricultural Fuel Oil Regulations (SSAFO) 2010, are now included within the new regulations. Storage systems which complied with the SSAFO standards are unlikely to need any changes. There is now a common standard applied to all oil storage in Wales. **However, the regulations remove an exemption for old agricultural fuel oil storage facilities which were in existence before 1991.**
